GENERAL RULES - FARELIST BETWEEN KUALA LUMPUR AND WARSAW

- 1) Fare validity : Valid for sales and ticketing made until 30th November 2009.
- 2) Flight booking : Strictly valid for travel on Malaysia Airlines & Lot Polish Airlines own operated flights only.
 - a) KUL / EUR / KUL or EUR / KUL / EUR
Only valid on MH own operated flights between KUL and FRA or LON or AMS or IST or PAR or ROM vv. Code share flights operated by other carriers are strictly not applicable.
 - b) EUR / WAW / EUR or WAW / EUR / WAW
Apply on LO own operated flights between WAW and FRA or LON or AMS or IST or PAR or ROM.
- 3) Child / Infant : CHD - 75% of adult fare / INF - 10% of adult fare.
- 4) Taxes : Fares quoted are excluded of departure taxes, fuel surcharges and all other relevant travel taxes.
- 5) Min / Max stay : Min stay is not applicable / Max stay is 12 months.
- 6) Ticketing deadline : Ticket must be issued 72 hours after reservation.
- 7) Ticket issuance : Tickets are to be issued by LOT Polish Airlines' GSA office in KUL only.
- 8) Open dated : Not permitted.
- 9) Stopover in EUROPE : All fares allowed stopover in Europe for both directions without airfare surcharge @ outbound or inbound. Relevant travel taxes must be paid accordingly.
- 10) Rebooking fee : Subject to USD50 rebooking fee and separate administration fee per change. Booking must be made in the same booking class.
- 11) Rerouting : Not permitted.
- 12) Refund : Fully unutilised ticket is subject to refund charge and administration fee for refund processing.
- 13) Payment : a) Cash
b) Credit Card acceptance only after perspective verification (3% merchant fee to be added)
c) Cheque payment to 'Global Alliance Travel Services Sdn Bhd' must be cleared before ticket release.

GENERAL RULES - BETWEEN WARSAW / POLAND AND EUROPE / MIDDLE EAST

- 1) Fare validity : Valid for sales and ticketing made until 30 November 2009. Fares quoted in MYR are strictly valid for travel on LOT Polish Airlines own operated flights only. Code share flights are not applicable.
- 2) Child / Infant : CHD - 67% of adult fare / INF - 10% of adult fare.
- 3) Taxes : Fares quoted are excluded of departure taxes, fuel surcharges and all other relevant travel taxes.
- 4) Mixed booking class : Permitted. Fares may be combined on a half round trip basis. However the more restrictive rules apply.
ie. WAW BCN (Q cls) + BCN WAW (V cls) MYR 895 (average of MYR 990 + MYR 800)
ie. MUC POZ (V cls) + POZ MUC (Q cls) MYR 1040 (average of MYR 950 + MYR 1130)
- 5) Min / Max stay : Min stay V class return fare is 2D/SU; not apply to Q class return and all one way fares.
Max stay V class return is 3 months; Q class return fare is 12 months.
- 6) Ticket issuance : Tickets are to be issued by LOT Polish Airlines' GSA office in KUL only.
- 7) Open dated : Not permitted.
- 8) Stopover : Unlimited stopovers permitted in Poland.
- 9) Rebooking fee : Subject to USD50 rebooking fee and separate administration fee per change.
Booking must be made in the same booking class.
- 10) Rerouting : Not permitted.
- 11) Refund : Fully unutilised ticket is subject to refund charge and administration fee for refund processing.
- 12) Payment : a) Cash
b) Credit Card acceptance only after perspective verification. (3% merchant fee to be added)
c) Cheque made payable to 'Global Alliance Travel Services Sdn Bhd' must be cleared before ticket release.
